Article 13: Canister

Article 14: Backhoe

To see if the town will vote to authorize the selectmen to enter into a 7 YEAR lease-purchase agreement, pursuant to RSA 33:7-e, in the amount of \$84,045 for the purpose of leasing a Backhoe Loader, and to raise and appropriate the sum of \$13,492 for the first year's payment for that purpose. This lease agreement contains an escape clause. Recommended by Board of Selectmen and Budget Committee. (Majority vote required)

ARTICLE PASSES

Article 15: Chipper

To see if the town will vote to raise and appropriate the sum of \$8,000 for the purpose of purchasing a used chipper, and said funds to come from the unassigned fund balance. Recommended Board of Selectmen and Budget Committee. (Majority vote required)

Article 16: Discontinue Dump Closure CRF

To see if the town will vote to discontinue the Dump Closure Capital Reserve Fund, said funds and accumulated interest to date of withdrawal, are to be transferred to the municipality's general fund. Recommended Board of Selectmen and Budget Committee. (Majority vote required)
