Hi, Alicea,

I hope you're having a good summer. Reviewing recent Planning and Zoning Board minutes there were two things that caught my eye. In the 5 July Planning Board meeting minutes, I noticed that Bruce Nadeau has been granted drive-through access at the Davis Pit. This reads as if this may be a privilege extended exclusively to Mr. Nadeau? Regardless, given the potential appearance of special favor granted to a Town Selectmen and Planning Board member, can you shed any light on this situation and decision by Shaun Carroll? (I note that this is ostensibly due to pending closure of Coon Brook Rd, but that doesn't explain why this courtesy has been extended to Mr. Nadeau.) Secondly, I note that Steve Bursey may now sit on both the Planning and Zoning Boards. If so, this would appear to be contrary to the explicit stipulations in the "Planning Board Rules of Procedure", specifically:

Planning Board members and alternates may also serve on any other municipal board or commission, provided that such multiple membership does not result in two or more Planning Board members or alternates serving on the same "other" board or commission. [RSA 673:7, I]
