Minutes of Meeting  
June 10, 2019

- The meeting came to order at 6:35 pm
- The check reports were reviewed and signed.
- Bonnie Belden, Library Trustee, stated the Library received a donation and disused what the library wants to do with the money. They are interested in create nature playground. No monies will come from the town. (Please see attached.)
- Jan stated a resident that property abuts Mill Village Cemetery brought the attention to Jesse West who was cutting a tree at the cemetery was on his property.
