Minutes of Meeting
June 22, 2020

The meeting came to order at 6:30 p.m.

- Check reports were reviewed and signed.
- Dianne made a motion to approve the minutes from the June 2nd & 8th meetings. Steve 2nd the motion.
- Sandy stated Kevin Dennis wants to speak with George from LCHIP in regards to the grange plans. Steve made a motion to allow Kevin Dennis to discuss changes to the plans to the grange. Diane 2nd the motion.

Dianne will talk with Gary Dennis in regards to the ramp for the grange. Dianne will speak to Gary to ask Brian Irwin to get a cost for the ramp to be installed.

- Bruce is writing a scope of work for Lempster Coach Road Bridge. The bridge is going to go out to bid. There will be a public hearing to discuss the use of the Class VI Rd to use to exit and enter while the bridge is being worked on.
- Ronnie Kempton stated he wants to donate 2 flag poles for the Cemeteries and knows someone that could installed them. Dianne stated the Cemetery Trustees need to be notified to see where the poles will be installed. The Select board thanked Ronnie for the donation. Dianne made a motion to accept the flag poles, Steve 2nd the motion. All in favor. Cindy will contact the Cemetery Trustees to invite them to attend a Select board meeting.
- Kevin stated Stevens has moved in to start the Rand Pond Rd project.

Gunnison lake was discussed to redo the signs. A new sign needs to be placed on Washington Road stating Main Parking with an arrow.

The rope swing needs to come down. The limbs on the tree will be cut so the rope cannot be put back up. An estimate will be done to get the cost.

Morrigan Corner Bridge on the Class VI Rd is not passable. The Select Board discussed different options to replace the bridge. This subject is tabled.

Kevin stated the new plow truck is on the floor in Burlington VT and the company is putting it together. A few changes were made at the cost of \$800. The truck should be completed 4 – 6 weeks.

Kevin stated he purchased barrels for the transfer station at \$10 apiece. The barrels will be used for sorting

- Chief Peterson stated the annual dinner at the fire station is cancelled. There still will have the chicken barbecue for pickup.,

Steve state the inmates from the House of Corrections will clean up Gunnison Lake. Kevin will help with removing the brush.

Steve stated he would like to see picnic tables at the lake.

Steve made a motion to adjourn the meeting at 8:34 p.m. Dianne 2nd the motion. All in favor.
